	1.1 Apologies: Apologies for absence were received from Cllr Knight and Cllr David Stamp 1.2 Disclosure of Interests: There were no disclosures made by Members of any Disclosable Pecuniary Interests (DPIs) and / or other interests arising under the Code of Conduct	
	1.3 Minutes: Minutes of the Parish Council meeting held on 20 th March 2020 were agreed and signed as a true record. Cllr Sayer advised that there was no legal issue regarding the crematorium application and needed to be removed from the draft minutes which the clerk actioned straight away.	
1	1.4 Matters Arising	
	Cllr Hammond advised that he has walked a number of footpaths in the parish. He reported that there are styles which are broken, he will report these to the Clerk.	
	Cllr Nosworthy advised there are a few styles near the Red Barn end of the parish. He will also report these to the Clerk	
	Cllr Hellard advised that there are a number of the footpaths mentioned in the Parish Green Book. She scanned a PDF version and emailed to all councillors	
(County and District Councillors Reports	
S	Cllr Wren reported that residents and visitors have complained that contractors on the Gas Holder site, have been wandering around whilst waiting collection or on breaks. Cllr Wren videoed the on goings, showing groups of 15 – 20 people. She involved TDC and the police to get the contractors to observe the social distancing requirements and found a resolution to the problem.	
	Cllr Sayer advised there was nothing further received from the Planning Inspector regarding the Local Plan	
A	A Judicial Review is being undertaken by Sevenoaks District Council regarding their Local Plan.	
c	There are still issues surrounding the proposed crematorium site, as they have not fulfilled a number of criteria required to move it forward. There is an issue with the Green Belt and the ANOB plus ssues surrounding the future 100 lorry movements from the sand pit and chalk pit.	
F S	County Councillor McIntosh advised that most government departments are shut down at present. He reported thought that Highways are mostly on top of all P1 defects and these will be completed shortly, such as larger pot holes. By next Friday they will be moving onto the P2 and P3 defects. The Environment bill will still be going ahead, however SCC are looking at becoming a unitary authority split into two divisions of East and West Surrey with the abolition of boroughs and districts.	
	Cllr McIntosh was disappointed with the outcome of the Chalk Pit. He has now suggested that a forum with Southern Gravel is set up to benefit the community.	
	There will be some restrictions enforced where Network Rail are working in Oxted.	
c	Cllr McIntosh advised of the challenges where contractors who are working on the highways have to observe the social distancing measures. Cllr David advised that the roads are quieter and people are using the highways more for cycling and walking, however there are a number of people using the quiet roads for racing cars. Cllr McIntosh has advised that more patrols are out in force and if there	



are particular issues he will chase these up with the police.

Cllr Hammond asked Cllr McIntosh if there was a fund for repairing such things that are not roadways. A resident has asked if Cllr McIntosh could look at the Common Land in the entrance at the church.

3. Parish Environment

3.1 Parish Councillors discussed hedge cutting in the car park and the Millennium Field Tandridge Parish Council confirmed that they would like to cancel the Wealdens contract and move forward with local contractors. Cllr David advised its currently nesting season and nothing can be done until the autumn.

- 3.3 Tandridge Parish Councillors received an update regarding the flag pole on Flag Pole Green. Councillor Hammond has an England flag and a VE Day commemoration flag. He wanted to know if the Parish Council would like to purchase Saints Day Flags and Cllr Hammond would put them up on the specific days. Cllr David, Cllr Stocker and Cllr Hellard were not pro regarding the idea at the present time.

2020/690 Land off Oxted Road (A25), Oxted

Proposal Erection of crematorium facility with associated memorial areas, landscaping, parking

and infrastructure.

Tandridge Parish Council have further comments regarding this application. The traffic that a crematorium would create would be dangerous on the A25 and also it is situated in AONB which would affect the Green Belt.

2020/496 Old Hall Farm Cottage, Tandridge Lane, Tandridge RH8 9NS

Proposal The application seeks permission to widen the existing access for the first 10m to

5.5m and incorporate a 6m radius on the north side for ease of turning provision for

larger agricultural vehicles and the weekly refuse collection vehicles.
