65.1	County Councillor MacIntosh's Report:
	Surrey County Council has spent £7million from Your Fund Surrey and will be setting the budget later in February.
	County Councillor MacIntosh reported that the dates now booked for The Walk to be resurfaced is 7 th to the 9 th February 2024 which was delayed due to bad weather.
	Southlands Lane and Jackass Lane will be projects that can be pushed forward for surface dressing by the end of this financial year.
	, Drainage is working well with the new installations on the A25
	Further surface dressing is due to be carried out on the A25 to join up the junction repairs
65.2	District Councillor Damesick's Report:
	In the process of putting together draft budget for 2024-25 and so far it is available to review prior to consultation and is balanced with out reducing services or grants at present. Reviewed by full council in February 2024. Tandridge District Council have had confirmation that the Local Plan is unsound and therefore Tandridge District Council will be pursuing a new plan as soon as possible. It has been confirmed that half the Biffa Depo will be developed in Hurst Green.
	system has been installed and Felbridge Parish Council successfully gained CIL funding for improving the playground. These are the most local projects.

Councillor Nosworthy asked for an update on larger recycling bins in the district which Cllr Damesick
advised reductions were due to a number of reasons including the misuse of these facilities.

	contacted their property team directly numerous times and is currently still awaiting a response!
66.2	Tandridge Parish Council discussed and confirmed actions regarding the Jubilee field
	The Parish Council agreed Roger Lampard did a good job on the clearance in the Jubilee Field.
	Councillors would like him to keep it under control and seek his advice for the best times to undertake
	the work. The council have a budget for this set at £600.00. The Clerk is contact and discuss this with
	Roger Lampard
66.3	Tandridge Parish Council discussed the Millenium field including the quotation received from Roger
	Lampard relating to the trees which need attention
	David Omahony current has the contract to maintain the Millennium Field, therefore the clerk is to
	request he clears the fallen Hawthorn which is covered with ivy on the school boundary.
	The sycamore tree may need further work so the clerk is to investigate this with Roger Lampard.
66.4	Tandridge Parish Council discussed suggested amalgamation with a neighbouring Parish Council. The
	clerk circulated some information from Tandridge District Council related to the protocol and legalities
	surrounding this suggestion.
	Cllr Schmidt stated that the 22/23 expenditure was around 18k and the 23/24 expenditure is looking to
	be £19/20k. He felt that the administration was too much and it was suggested that the clerks work could
	be undertaken to by the Councillors to reduce the hours and processes. The clerk advise that this is not
	appropriate and disagreed strongly with the suggestion as the role of a clerk and the role of a councillor are completely different.
	The clerk pointed out that this was confirmed by the then Head of SSALC Anne Bott a couple of year
	before who deemed the Clerks role at Tandridge Parish Council and the hours undertaken to be correct.
	The clerk advised that there is a Councillor training course available to learn about the role of the Parish
	Councillor and also the role of the Clerk.
	The clerk will send details of the training courses for those who wish to attend.
