46.	PROCEDURAL MATTERS
46.1	Apologies: Apologies for absence were received from District Councillor Liz Lockwood, Cllr Nosworthy
46.2	Disclosure of Interests: There were no disclosures by Members of any Disclosable Pecuniary Interests (DPIs) and / or other interests arising under the Code of Conduct
46.3	Public questions: The first ten minutes of the meeting are available for members of the public to raise questions about and comment on items on the agenda. None present
46.4	Minutes: Minutes of the Parish Council meeting held on the 7 th October 2025, were agreed and signed as a true record.

47.	REPORTS
47.1	<p>County Councillor Report</p> <p>Fly tipping – closing road, ANPR etc suggested options have been advised that it is a long, expensive and legal process with DfT. All costs would then have to be taken on by the residents.</p> <p>Identification found in the fly tipping is passed to the police to trace the culprits.</p> <p>Cllr David to send the Clerk contact details for the land owners re permission for signage in field re “This area being monitored”</p> <p>A25 roundabout – needs refurbishment and residents want to advertise on it through a sponsorship scheme. However in this area there is not a scheme to allow for advertising</p> <p>Cllr McIntosh has requested funding for coping stones on the roundabout</p> <p>The head at the infant school got in contact re – school safety outside the school – put forward to the road safety outside schools</p> <p>Sight assessment will be carried out in 2026 which includes a police review</p> <p>Bollards, VAS, Village Signs, Ample Parking and a very straight road – assessment will deem if anything further can be done.</p> <p>Banking Hub = Cllr McIntosh is trying to get one in Oxted. Assessment in 2024 was carried out by LINK – they did not follow their own process regarding access to cash. If they don’t meet the criteria then they</p>

	<p>will recommend a HUB. The population was incorrectly recorded and the assessment was challenged. The MP has written to the Minister and we await a response in due course. Cllr McIntosh has requested support of the Parish Council which was agreed</p>
47.2	<p>District Councillor Report</p> <ol style="list-style-type: none"> 1. The government has decided to split Surrey into 2 unitaries, with Tandridge being in the new East Surrey, and has made a contribution of £500m to Woking's debt as a compromise, although that's really a drop in the ocean when looking at the combined debt of Woking and Spelthorne. At least it shows that there is an intention for the new authorities not to have to cover all of the bad debts going forward. Elections for the new councillors will happen in May 2026. No information yet as to whether it will be 2 or 3 division councillors, but it will be for the new areas agreed by the electoral commission with Crowhurst and Tandridge Parish being part of the Godstone Division. 2. No news yet of the HELAA sites going to district councillors yet, there was an agreement that ward members will meet with officers early in November and nothing announced to date. Tandridge have started making contact for the emerging local plan and to get onto the email list for news as it is published sign up to localplan@tandridge.gov.uk. 3. Remembrance Sunday - Hopefully your newly elected district councillor should be attending the Remembrance wreath laying and service this Sunday, I have been nominated by the Council to attend the one at Crowhurst, as there is a set order in which councillors are asked to attend the 3 ward churches. 4. Planning: No result yet regarding the application for the screening opinion for the "Pale Park Village" but interestingly a very robust response has come from the Environmental Health officers regarding the known landfill sites and leaking gas on Postern Gate Farm land and Naturescape reports that full ecology surveys will need to be undertaken. Buttons Mead Farm - The Upper Medway Drainage Board are following up the unlicenced discharge of waste water into the roadside ditches. Even if it is only rainwater runoff from the buildings, it requires a licence to discharge into road ditches. The extra discharge for the newly extended barn is adding to the flooding on the road a little further north of the farm, which has had a lot of work done by Surrey Highways to resolve previous issues. This is potentially just going to make those works redundant! Although Buttons Mead is technically in Godstone, the flooding impacts Tandridge Parish residents. The reported felling of Ancient Woodland trees on site is being followed up by the Forestry Commission as a licence is required and I have requests a TPO be put onto all the Ancient Woodland on site as there is a potential risk of more felling.
